

Release of Liability for Activities with Rancho El Camino

The undersigned (herein the "Volunteer") and any dependents listed, wish to travel and participate in a short-term volunteering trip (herein the "Activity") to Rancho El Camino (herein "The Ranch"), who will be receiving you. The Volunteer enters into this Release of Liability (herein the "Release").

The Ranch and the Volunteer agree that the Activity poses risks including, but not limited to, the following specific risks: hazardous traffic, high altitude, extreme temperatures, snake bites, equine dangers, dangerous bugs, bacteria, parasites, strenuous outdoor activities, primitive living, operating in remote areas in which rescue may take several hours or even days, sickness, disease, loss of life, crime, political instability, military activity, bandits, kidnapping, government opposition to religious activities, terrorism, as well as similar and dissimilar risks (herein the "Risks"). The Volunteer also gives permission to The Ranch to use pictures and video footage of him/her for brochures, websites, newsletters, and other hardcopy and electronic publications.

For and in consideration of The Ranch assisting the Volunteer in the Activity, and other good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, the Volunteer for himself/herself and his/her personal and legal representatives, family members, assigns, heirs, beneficiaries, successors, guardians and next of kin (herein the "Releasers"), hereby irrevocably and unconditionally releases, waives, discharges and covenants not to sue The Ranch and its affiliates, partners, Parent organizations, divisions, members of its board of directors, officers, employees, members, volunteers and agents (herein the "Releasees"), for and from all claims of any nature now or hereafter existing, whether known or unknown, including but not limited to, all liability to the Releasers, on account of injury to the Volunteer, death to the Volunteer, or injury to the property of the Volunteer, whether caused by the negligence of Releasees or otherwise, while the Volunteer is participating in the Activity. The Volunteer is fully aware of the Risks and other hazards inherent in the Activity, and voluntarily assumes the Risks and all other risks of loss, damage, or injury that may be sustained by the Volunteer while participating in the Activity.

The Volunteer further agrees that he/she bears the sole responsibility for any and all travel expenses which he/she incurs in the event his/her Activity leader or other The Ranch leadership finds it necessary to send the Volunteer home at a time different from the scheduled departure date, whether for health or physical limitations or inappropriate or immoral behavior, as determined by The Ranch, and whether required during the Volunteer's participation in the Activity or not. The Volunteer acknowledges Releasees are under no obligation to, and do not, cover travel expenses for the Volunteer.

The volunteer agrees to hold The Ranch harmless for any decisions the individual makes on behalf of him/herself or his/her dependents as concerns medical preparation to travel and work in the Ranch volunteer environments.

The Volunteer agrees to abide by all rules, regulations, and guidelines set forth by the Releasees, and to abide by all decisions made by all leaders and those in authority related to the Activity. The Volunteer warrants that he/she has fully read and understands this Liability Release Agreement and voluntarily signs the same, and that no oral representations, statements, or inducements apart from the foregoing written agreement have been made to the Volunteer.
